

**94.7 WCSX 80's in the Sand
OFFICIAL RULES**

These rules apply to the WCSX 80's in the Sand Contest ("Contest") conducted by **Beasley Media Group, LLC d/b/a WCSX** ("Station"). **In addition, the General Contest Rules posted at wcsx.com apply to this Contest. If there is a conflict between the General Contest Rules and the Rules for this Contest, the Rules for this Contest shall control.**

1. HOW TO ENTER

- a. The Contest will begin on January 28, 2019 and end on February 22, 2019.
- b. To participate in the Contest, entrant may qualify on-air, on-site or online as follows:
 - 1) To enter on-air, listen to the Station each weekday beginning on January 28, 2019 and ending on February 22, 2019 between the hours of 6:00a.m. Eastern Time ("ET") and 11:00p.m. ET for the announcement of the cue to call. Upon hearing the cue to call, caller number thirty-one (31) to the Station contest line at (248) 398-WCSX will be deemed a "Qualifier" and will be eligible to participate in the Event, as described below, for a chance to win the Grand Prize, upon confirmation of eligibility. Station is not responsible for any failure of a caller to reach the Station contest line including but not limited to busy phone lines, misdirected calls, equipment breakdowns, or disconnections. Calls will only be accepted at the designated phone number. At the time of entrant's call, entrant will be required to provide all information requested including entrant's full name, complete address (including zip code), day and evening phone numbers and date of birth in order to be eligible to win. P.O. Boxes are not permitted. In the event that the selected caller is disconnected or is found to be ineligible, the next eligible caller who successfully makes it through on the call-in line and completes the call will be a Qualifier. There is no limit to the number of times a listener may attempt to call in to win, but a listener may be a Qualifier only once.

Up to fifty (50) Qualifiers will be selected and notified through this method.

- 2) To enter on-site, visit one of up to eight possible Contest appearances that will take place from January 28, 2019 through February 22, 2019 in the metro Detroit area. Listeners will be notified of appearance dates, times and locations via on-air broadcasts and on the Contest web page located at www.wcsx.com. Limit one (1) entry per person per appearance. All entry forms must be filled out completely and legibly and submitted as instructed by the Station. Incomplete or illegible entries may be removed in the Station's sole discretion. Entries must be received by the designated end time.

Up to five (5) Qualifiers will be selected in a Station-conducted random drawing at the conclusion of each appearance as announced on-site by the Station from

all eligible on-site entries received at that appearance (up to forty (40) total Qualifiers may be selected via this method). Qualifiers will be notified on-site if present or by phone promptly following the random drawing. Non-selected entries will not rollover into subsequent on-site random drawings.

- 3) To enter online, visit www.wcsx.com and follow the links and instructions to enter the Contest and complete and submit the online entry form beginning at 12:01am ET on January 28, 2019 and ending at 10:00am ET on February 18, 2019 (“Online Entry Period”). Online entrants are subject to all notices posted online including but not limited to the Station's Privacy Policy. Limit one (1) entry per eligible person during the Online Entry Period regardless if entrant has more than one email address. Multiple participants are not permitted to share the same email address. Entries submitted may not be acknowledged or returned. Proof of submission of an entry shall not be deemed proof of receipt by the Contest administrator.

Up to four (4) Qualifiers will be selected at approximately 10:00am ET on February 18, 2019 in a Station-conducted random drawing from all eligible online entries received. Online Qualifiers will be notified by telephone promptly following the random drawing. If any online Qualifier cannot be contacted within twenty-four (24) hours after notification, an alternate online Qualifier(s) may be selected in a Station-conducted random drawing from all remaining eligible online entries received. The Station reserves the right but not the obligation to select additional online Qualifiers if there are fewer than eight (8) Contest appearances as described above, so that the total number of Qualifiers from all three methods is ninety-four (94).

- c. There will be up to a total of ninety-four (94) Qualifiers and one (1) Grand Prize winner selected in the Contest. **Limit one (1) Qualifier per household, regardless of method selected.**

2. ELIGIBILITY RESTRICTIONS

- a. This Contest is open to all Station listeners who are 21 years of age or older as of the date of entry into the Contest, who are legal US residents and reside in the following Michigan counties: Lenawee, Monroe, Wayne, Washtenaw, Jackson, Hillsdale, Ingham, Livingston, Oakland, Macomb, St. Clair, Lapeer, Genesee, and Shiawassee; and the following Ohio Counties: Lucas, Fulton, and Williams, except where prohibited by law. Winners must possess a valid, government-issued ID and show proof of residency to verify eligibility.
- b. Employees of Kapones Sports Tavern, R&R Productions LLC, the Station, its licensee, its parent corporation, their affiliated entities, affiliated advertising agencies, participating sponsors/promotional partners, other radio stations in the Detroit Metro Survey Area and the members of their immediate families are ineligible to participate or win. The term “immediate family” includes spouses, siblings, parents and legal guardians, children and legal wards, grandparents, and grandchildren, including “in-laws.”

- c. Persons are eligible to win a Station contest only once every Thirty (30) days and a prize valued at \$600 or more, only once every sixty (60) days. Only one winner per household (whether related or not) is permitted in any contest. PER WCSX GENERAL CONTEST RULES

3. PRIZES

- a. Up to one (1) Grand Prize will be awarded. The Grand Prize consists of a trip for two (2) people (Winner and one guest, age 21+) to the 80's In The Sand event at the Breathless Resort & Spa in Punta Cana, Dominican Republic taking place from November 2, 2019 through November 9, 2019. Grand Prize includes:
- Seven (7) night hotel accommodations (standard room, double occupancy) at the Breathless Resort & Spa in Punta Cana Dominican Republic for two (2) adults;
 - Ground transfers to/from the Breathless Resort & Spa and Punta Cana airport;
 - Meals for two (2) people at the Breathless Resort & Spa;
 - Beverages, alcoholic and non-alcoholic, for two (2) people at the Breathless Resort & Spa;
 - Access to entertainment and events at the Breathless Resort & Spa;
 - One thousand three hundred dollars (\$1,300) (awarded in the form of a company check issued in the name of the winner) to be used towards the purchase of the flights for winner and one (1) guest to and from Punta Cana. **Winner is solely responsible for booking winner and guest airfare. The Station is not responsible for any airfare costs greater than \$1,300.**

Approximate Retail Value of the Grand Prize is \$5,400.

Actual value may vary and any difference between stated value and actual value will not be awarded. Certain travel restrictions may apply. All other costs not specifically stated herein, including but not limited to those of, taxes, meals, tips and additional ground transportation, baggage fees, hotel room service, laundry service, alcoholic beverages, merchandise, souvenirs, and local and long-distance telephone calls are the responsibility of the winner. Selection of airline, hotel, and airline seat location at sole discretion of Station and/or prize provider. Airline regulations apply. The winner and guest must travel on the same itinerary and are responsible for obtaining all required travel documents, including, without limitation, passports for international travel. If applicable, the winner may be required to present a valid credit card upon hotel check in to cover any incidental expenses incurred during the winner's stay. Winner and guest must abide by all airline, hotel, and venue policies. The winner and guest must sign all required releases prior to booking of any travel. If winner is unwilling or unable to travel on the dates specified, the prize will be forfeited and may be awarded to another winner at Station's sole discretion. All travel is subject to availability and restrictions. If a prize-related event or travel is unable to take place as scheduled, for reasons such as cancellation, preemption, postponement or unavailability, including for weather, or for any reason beyond the control of the Station and prize provider, their sole responsibility to the winner will be to

award the remaining available elements of the prize(s) and no substitution or compensation will be provided for the unawarded elements of the prize(s). No refund or compensation will be made in the event of the cancellation or delay of any flight. If winner chooses to take the trip without a guest, s/he will be awarded the prize elements for one person only, and the remainder of the prize will be forfeited without compensation. Winner understands that there are inherent risks involved in travel and that these risks may be present before, during and after the trip.

No check will be awarded, processed or mailed until winner has claimed the prize at the Station, presented all required documentation, and signed all required releases and tax forms. Checks will then be mailed within approximately thirty (30) days following confirmation of eligibility and completion of all requisite releases and IRS forms.

- b. Prizes or prize certificates must be claimed at the office of the Station located at One Radio Plaza, Detroit, MI 48220, Monday-Friday, during regular business hours. Prize or prize certificate must be claimed within thirty (30) days of winning. Failure to claim Prize by the specified time will result in forfeiture of the prize. It is the winner's sole responsibility to claim the Prize or prize certificate within the timeline provided in these Official Rules.

4. SELECTION OF WINNER

- a. Up to ninety-four (94) Qualifiers will be selected and notified as described above. **There is no prize associated with being deemed a Qualifier.**
- b. Up to one (1) Grand Prize winner will be selected as follows:

All Qualifiers must be present and check-in with the Station at the Grand Prize Event ("Event") at Kapones Sports Tavern, located at 24301 Harper Ave, St. Clair Shores, MI 48080, on Friday, February 22, 2019 between 6:30pm ET and 7:45pm ET to be eligible to win the Grand Prize. Any Qualifiers not present and checked in by 7:45pm ET will be disqualified forfeit their chance to win the Grand Prize. Station reserves the right but not the obligation to randomly select alternate Qualifier(s) at the Event via on-site registrations to fill all ninety-four (94) Qualifier spots for the Contest.

Each Qualifier in attendance will be requested to draw a number out of a container at random. The number will determine the order in which each Qualifier will go to the designated Contest Flip Flop Wall and choose one (1) of the ninety-four (94) Flip Flops that will be hung on the wall. Each Flip Flop has a number on the back of it from one (1) to ninety-four (94), inclusively. Once all Qualifiers have selected their Flip Flop from the wall, a winning number will be randomly selected and announced by the Station. The Qualifier who selected the Flip Flop with the winning number on the back will win the Grand Prize, upon confirmation of eligibility.

- c. Odds of being selected as an on-air Qualifier depend on the order and number and order of calls received. Odds of being selected as an on-site Qualifier depend on the number of

eligible on-site entries received at each appearance. Odds of being selected as an online Qualifier depend on the number of eligible online entries received. Odds of a Qualifier being selected as a Grand Prize winner are 1 in 94.

- d. On-air entrants must listen to the Station but need not be present to qualify. On-site entrants need not listen to the Station but must be present to enter and qualify. Online entrants need not listen to the Station or be present to qualify. Qualifiers need not listen to the Station must be present at the Event to be eligible to win the Grand Prize.
- e. Decisions of Station management with respect to the Contest are final.

- a. The Station reserves the right to end any contest or amend these rules upon announcement on air and by publication at www.wcsx.com.
