

WCSX- Big Jim's House The Sands!
Official Contest Rules

These rules apply to **94.7 WCSX Big Jim's House The Sands!** Contest ("Contest") conducted by **Beasley Media Group, LLC d/b/a WCSX** ("Station"). **In addition, the General Contest Rules posted at www.wcsx.com apply to this Contest. If there is a conflict between the General Contest Rules and the Rules for this Contest, the Rules for this Contest shall control.**

1. HOW TO ENTER

- a. The Contest will begin on January 17, 2023 and end on February 10, 2023.
- b. To enter online, visit www.wcsx.com and follow the links and instructions to enter the Contest and complete and submit the online entry form beginning on January 17, 2023 at 6:00am Eastern Time ("ET") and ending on February 9, 2023 at 11:59pm ET ("Online Entry Period"). Online entrants are subject to all notices posted online including but not limited to the Station's Privacy Policy. Multiple entrants are not permitted to share the same email address. Entries submitted may not be acknowledged or returned. Proof of submission of an entry shall not be deemed proof of receipt by the Contest administrator.
- c. Each weekday beginning on Tuesday, January 17, 2023 and ending on Friday, February 10, 2023, up to two (2) entries will be selected in a Station-conducted random drawing from all eligible online entries received up until the time of the drawing. Selected entrants will be qualified for a chance to win a weekly Grand Prize (each deemed a "Qualifier"), upon confirmation of eligibility. The first potential Qualifier will be selected at approximately 7:40am ET, and the second potential Qualifier will be selected at approximately 9:20am ET each weekday. Qualifiers' names may be announced on air during Big Jim's House each weekday. Entries not selected will remain in the pool of entries that may be selected during subsequent drawings in this Contest.
- d. There will be up to a total of one (1) Grand Prize winner selected in the Contest. **An entrant may only be deemed a Qualifier once.**

2. ELIGIBILITY RESTRICTIONS

- a. This Contest is open to all Station listeners who are 21 years of age or older as of the date of entry into the Contest, who are legal US residents and reside in the Detroit Metro Area, consisting of the following Michigan counties: Lenawee, Monroe, Wayne, Washtenaw, Jackson, Hillsdale, Ingham, Livingston, Oakland, Macomb, St. Clair, Lapeer, Genesee, and Shiawassee; and the following Ohio Counties: Lucas, Fulton, and

Williams, except where prohibited by law. Winners must possess a valid, government-issued ID and show proof of residency to verify eligibility.

b. Limit one (1) Qualifier/winner per household.

3. PRIZES

a. Up to one (1) Grand Prize will be awarded. The Grand Prize consists of a trip for two (2) people (Winner and one guest, age 21+) to The Sands event at Planet Hollywood Beach Resort in Cancun Mexico on November 6-11, 2023. Grand Prize includes: (i) One (1) All Inclusive Junior Suite room for five (5) nights for two (2) people at Planet Hollywood Beach Resort in Cancun Mexico on November 6-11, 2023 for The Sands event; (ii) meals and beverages (alcoholic and non-alcoholic) during the stay; (iii) ground transportation to/from the resort and the airport in Cancun Mexico; (iv) access to events at the resort during the stay; and (v) One thousand three hundred dollars (\$1,300) (awarded in the form of a company check issued in the name of the winner) to be used towards the purchase of the flights for winner and one (1) guest to and from Cancun. **Winner is solely responsible for booking winner and guest airfare. The Station is not responsible for any airfare or travel-related costs greater than \$1,300.**

Approximate Retail Value of the Grand Prize is \$5,300. Actual value may vary and any difference between stated value and actual value will not be awarded. Certain travel restrictions may apply. All other costs not specifically stated herein, including but not limited to those of, taxes, meals, tips and additional ground transportation, baggage fees, hotel room service, laundry service, alcoholic beverages, merchandise, souvenirs, and local and long-distance telephone calls are the responsibility of the winner. Selection of airline, hotel, and airline seat location at sole discretion of Station and/or prize provider. Airline regulations apply. The winner and guest must travel on the same itinerary and are responsible for obtaining all required travel documents, including, without limitation, passports for international travel. If applicable, the winner may be required to present a valid credit card upon hotel check in to cover any incidental expenses incurred during the winner's stay. Winner and guest must abide by all airline, hotel, and venue policies. The winner and guest must sign all required releases prior to booking of any travel. If winner is unwilling or unable to travel on the dates specified, the prize will be forfeited and may be awarded to another winner at Station's sole discretion. All travel is subject to availability and restrictions. If a prize-related event or travel is unable to take place as scheduled, for reasons such as cancellation, preemption, postponement or unavailability, including for weather, or for any reason beyond the control of the Station and prize provider, their sole responsibility to the winner will be to award the remaining available elements of the prize(s) and no substitution or compensation will

be provided for the unawarded elements of the prize(s). No refund or compensation will be made in the event of the cancellation or delay of any flight. If winner chooses to take the trip without a guest, s/he will be awarded the prize elements for one person only, and the remainder of the prize will be forfeited without compensation. Winner understands that there are inherent risks involved in travel and that these risks may be present before, during and after the trip. In addition, winner and guest(s) should be aware of and comply with government guidelines regarding travel restrictions and mandatory quarantines before, during and after the trip.

No check will be awarded, processed or mailed until winner has claimed the prize at the Station, presented all required documentation, and signed all required releases and tax forms. Checks will then be mailed within approximately four (4) to six (6) weeks following confirmation of eligibility and completion of all requisite releases and IRS forms.

- b. Prizes or prize certificates must be claimed at the office of the Station located at One Radio Plaza, Detroit, MI 48220, Monday-Friday, during regular business hours. Prize or prize certificate must be claimed within ten (10) days of winning. Failure to claim Prize by the specified time will result in forfeiture of the prize. It is the winner's sole responsibility to claim the Prize or prize certificate within the timeline provided in these Official Rules.

4. SELECTION OF WINNERS

- a. Up to one (1) Grand Prize winner will be selected at approximately 10:00am ET on Friday February 10, 2023 in a Station-conducted random drawing from all Qualifiers selected. Potential Grand Prize winner will be notified by telephone promptly following the random drawing.
- b. Odds of being deemed a Qualifier depend on the number of eligible online entries received at the time of each random drawing. Odds of a Qualifier winning the Grand Prize are up to 1 in 38.
- c. Entrants need not listen to the Station or be present to be deemed a Qualifier online. Qualifiers need not listen to the Station or be present to win the Grand Prize.
- d. Grand Prize winner must confirm acceptance of prize within ten (10) days of winning, or risk disqualification and selection of an alternate Grand Prize winner (time permitting) in a random drawing of all remaining Qualifiers.
- e. Decisions of Station management with respect to the Contest are final.
